



Pet Hotel CAT Boarding Agreement & Release of Liability

1. I understand and agree that **Boxers Bed & Biscuits** (its staff, owners, contractors and agents collectively) will not be liable for any problems, damages, or injuries caused by my Cat(s) during its/their stay at the Pet Hotel. I, the Cat Owner (or Owner's Authorized Representative), agree to be solely responsible for any and all acts of behavior of my Cat(s) while in the care of **Boxers Bed & Biscuits**. I hereby release **Boxers Bed & Biscuits** from any liability arising from my Cat's attendance.
2. I understand and agree that in admitting my Cat(s) to **Boxers Bed & Biscuits**, the Hotel Staff has relied on my representation that my Cat(s) is/are in good health and has/have not harmed or shown aggressive or threatening behavior towards any person.
3. I hereby certify that my Cat(s) is/are in good health and has/have not been ill with any communicable diseases in the 30 days prior to check-in. In the event that my Cat(s) become(s) ill or injured to the point of requiring medical treatment, as determined by Hotel Staff, **Boxers Bed & Biscuits** will make every attempt to contact me or my emergency contacts and/or my veterinarian on file for further instruction. If the illness or injury appears to be life-threatening, as determined by Hotel Staff, my Cat(s) will be taken to a local veterinarian chosen by Hotel Staff. I also understand that such emergency veterinary expenses shall be reimbursed by me directly to **Boxers Bed & Biscuits**.
4. **Boxers Bed & Biscuits** agrees to exercise due and reasonable care for my Cat(s). I, the Owner or Responsible Party, release **Boxers Bed & Biscuits** from any claims made against the Hotel or its employees or agents or losses or damages of any kind suffered by **Boxers Bed & Biscuits** for, or attributable to, any illness or injury of Cat(s). I agree that I shall be responsible for costs of injury to Hotel Staff or damage to the facility caused by my Cat(s). Also, I indemnify **Boxers Bed & Biscuits** as a result of my failure to inform Hotel Staff about my Cat(s) illness or aggression problems, or which were otherwise caused by my Cat(s). Also, if my Cat(s) is/are transported by **Boxers Bed & Biscuits**, I will not hold **Boxers Bed & Biscuits** or its Staff responsible for any injury or accident during transportation. It is expressly agreed by me and the Hotel that **Boxers Bed & Biscuits'** liability shall, in no event, exceed the lesser of the current chattel value of a Cat of the same breed or the sum of \$200 per Cat.
5. I understand that if I leave my Cat(s) at **Boxers Bed & Biscuits** for a period of 5 days beyond the scheduled ending date of its/their stay, my Cat(s) will be considered abandoned and necessary steps will be taken to turn the Cat(s) over to the proper authorities.
6. I certify that I have carefully read and understand the policies of **Boxers Bed & Biscuits** as set forth in this document and that I have read and understand the conditions and statements of this agreement.
